The Certified Prevention Specialist is an individual who has demonstrated competence related to alcohol, tobacco and drug prevention and who provides services that build the capacity of individuals and systems to promote healthy environments, lifestyles, and communities.

## **About the Trainers:**

### **Wade E. Bishop, CSPS, ICPS**

Wade Bishop was born in Philadelphia, PA., is a 1976 graduate of Penn State University w/ a degree from the College of Human Development, majoring in Individual & Family Studies. He moved to Beaufort, SC the day after graduation. He has been employed w/ Beaufort County Alcohol & Drug Abuse Dept. for over 25 years and has held his current position as the Director of Prevention Services for over 5 yrs. Wade received the "N. Pete Johnson Award" in 2003 from the South Carolina Association of Prevention Professionals and Advocates (SCAPPA), for recognition as the "Prevention Professional of the Year". He received a "Certificate of Honor" from The International Certification & Reciprocity Consortium, as South Carolina's 2011 nominee for Prevention Specialist of The Year. He has done extensive volunteer work in the Beaufort area w/ children's issues and was recognized as the "Volunteer of the Year" 1995, by the local Child Abuse Prevention Agency (CAPA). He was the co-founder of Beaufort's annual "Ghost Tours", a major fundraiser for CAPA. He has served on the Board's for both CAPA & Hope Haven and continues his volunteer service with Hope Haven.

### **Ashley Bodiford, MPH, CSPS, ICPS**

Ashley Bodiford is the Regional Capacity Coach at LRADAC for Region II of South Carolina in which she provides training, coaching and technical assistance to help to ensure readiness for implementation of the strategic prevention framework. At LRADAC, she has also served as the Alcohol Enforcement Team Coordinator for the 5<sup>th</sup> and 11<sup>th</sup> judicial circuits in which she developed and implemented programs to reduce underage drinking and impaired driving. Mrs. Bodiford has worked in the field of substance use prevention for 7 years and serves on several key state wide task forces and committees. She is a Certified Senior Prevention Specialist (CSPS), a certified trainer for the Substance Abuse Prevention Skills Training (SAPST), and the Palmetto Retailers Education Program (PREP). She has also served as a trainer for the Office of Juvenile Justice and Delinquency Prevention Program (OJJDP) in Washington, DC. Mrs. Bodiford has served on the South Carolina Association of Prevention Professionals and Advocates (SCAPPA) board for several years. Mrs. Bodiford holds a Bachelor of Science in Developmental Psychology and a Master of Public Health. In 2012 she was named the recipient of the Jan Oglietti Rising Star Prevention Professional award for outstanding contributions to the field of prevention and in 2016 was named the recipient of the Norman Peter Johnson Outstanding Prevention Professional Award.

### **Matthew C. Hall**

Matthew Hall is a South Carolina native, serves as Government Affairs Analyst for Capitol Consultants. He is also the Administrator for the South Carolina Association for Prevention Professionals and Advocates. Matthew attended the University of South Carolina where he graduated with a degree in Economics. Prior to joining Capitol Consultants, Matthew was employed by the South Carolina House of Representatives, the South Carolina Senate Finance Committee, and the Central SC Alliance with a focus on Economic Development Research & Marketing.

### **Wehme Appleby Hutto, MPA, CSPS, ICPS**

Wehme Hutto is the Director of Prevention & Community Services at the Ernest E. Kennedy Center in Berkeley County, SC, a position she has held since 1995. She holds a Master of Public Administration with an emphasis in non-profit and local government administration from the College of Charleston. She completed her BA from Clemson University majoring in Political Science. She is a Certified Senior Prevention Specialist (CSPS) through SCAPPA (South Carolina Association of Prevention Professionals & Advocates) and an Internationally Certified Prevention Specialist (ICPS) through IC&RC (International Certification & Reciprocity Consortium). She has coordinated the 9<sup>th</sup> Judicial Circuit Alcohol Enforcement Team (AET) since its inception in 2007. She also has served as both a state and federal grant reviewer. Hutto currently serves as the state Chairperson for the SCAPPA Certification Commission, which is the certifying body for South Carolina's prevention professionals. In addition, she represents the state of SC as the voting delegate to the IC&RC., where she is a member of the Prevention Professional of the Year Selection Committee and the Prevention Ethics Workgroup. Locally she is the Treasurer of the Smoke-Free Low country Coalition, Chairperson of the Berkeley County Prevention Board, a member of the RU21 Team and the Trident United Way Data Workgroup.

**Jeff McAninch, CSPS, ICPS**

Jeff McAninch is a Certified Senior Prevention Specialist with the Phoenix Center of Greenville, South Carolina, Greenville County's Commission on Alcohol and Drug Abuse. In October of 2004 Jeff began working the Phoenix Center of Greenville where he currently serves as Prevention Department Coordinator for the commission. During his time at the Phoenix Center, Jeff has served in the areas of Community Based Outreach, Medicaid Case Management, REACH Leadership and Resiliency Program Coordinator, Lead Prevention Specialist, and Prevention Department Coordinator. Jeff has served on many state and local coalitions and committees such as the Behavioral Health Services Administration (BHSA) Prevention Committee and the Blunt Truth South Carolina Marijuana Taskforce. Certified Senior Prevention Specialists are credentialed through the South Carolina Association of Prevention Professionals and Advocates (SCAPPA) as well as the International Certification and Reciprocity Consortium (IC&RC).

**Amanda Prince, CSPS**

Amanda Prince is the Prevention Director for Gateway Counseling Center located in Laurens, SC, and a member of the Laurens County Prevention Coalition. Amanda has worked in the alcohol and drug abuse prevention field for 27 years. She began working under an Office of Substance Abuse Prevention grant in 1991 that brought together sectors of the community to pinpoint the factors that lead to particular alcohol and other drug abuse problems in the community. After the grant funding ended, she remained in the field of prevention. In 2010 she became the Community Action for a Safer Tomorrow (CAST) Coordinator and began forming a community coalition charged with reducing the DUI crash rate in Laurens County. Utilizing the Strategic Prevention Framework model the coalition worked to reduce the DUI crash rate. The coalition remains active today, almost 3 years after the federal funding stream ended, and continues to explore ways to address the needs of the community.

**Melody C. Reid, CSPS, ICPS**

Melody C. Reid serves as the Director of Prevention Services at the Hazel Pittman Center in Chester County. She also serves as the Alcohol Enforcement Team Coordinator for the 6<sup>th</sup> Judicial Circuit which serves Chester, Fairfield, and Lancaster County. She has 20 years' experience in the field of Prevention/Education and facilitating support services at the local and state level. Has the ability to plan, implement and evaluate various programs, prevention and intervention to the public. From 1998 to present, Melody has worked in developing and implementing programs for youth of all ages, which include educational presentations using evidence-based curriculum and conducting groups, and is also skilled in working with high-risk youth populations. Supervises and coordinates all aspects of the Alcohol Enforcement Teams focusing on underage drinking. She serves on various community coalitions in Chester, Fairfield, and Lancaster Counties. She serves as Coalition Chair for the Chester County Community Coalition and Eat Smart, Move More Chester County. She also serves on various boards in her work community. Melody is a graduate of King's College in Charlotte, NC. She currently resides in Lancaster, SC the proud Red Rose City. She spends much of her time with her better half and her three adorable children, Sean, Alexa, and her wonderful little surprise Austin, and a host of family members and friends.

**Renee Bradley Wiley, BA, CPS**

Renee Bradley Wiley serves as the Coordinator of Prevention Services for Williamsburg County Department on Alcohol and Drug Abuse, and has worked in the field of Prevention since 2000. She has implemented a variety of grant funded prevention education programs, such as Drug Free Communities, Safe and Drug Schools, and HIV/AIDS Prevention.
